5. To provide software support, maintenance, troubleshooting, version upgrades, bug fixing, and related services to clients through remote and on-site channels.

6. To offer IT-enabled services including website design and development, digital marketing, search engine optimization (SEO), business automation tools, CRM (Customer Relationship Management), ERP (Enterprise Resource Planning), and other business productivity solutions.

7. To provide consultancy and advisory services in the areas of business growth, brand development, sales optimization, market expansion, digital transformation, lead generation, and profitability improvement using both offline and online strategies.

8. To create, establish, operate, and manage online marketplaces, e-commerce platforms, B2B and B2C directories, and digital service hubs for promoting and supporting local, national, and global businesses.

9. To conduct seminars, webinars, conferences, training programs, and workshops, both online and offline, in the fields of business development, marketing, entrepreneurship, personal growth, and direct selling.

10. To publish, produce, sell, and distribute books, e-books, videos, podcasts, online courses, training modules, and other multimedia content for skill development, motivation, and business education.

11. To engage in import, export, marketing, wholesale,



and retail trading of goods, tools, products, and services connected with the company's business activities, including IT gadgets, health and wellness products, and business equipment.

partnerships, joint ventures, alliances, or collaborations with individuals, firms, or companies in India or abroad having similar or complementary objectives.

20. To undertake all such lawful activities as may be necessary, incidental, or conducive to the attainment of the above objects, subject to the applicable laws of India and other jurisdictions in which the company operates.

1. To purchase, exchange or otherwise deal with any movable or immovable property and any rights or privileges which the Company may deem necessary or convenient for the purpose of its main business.

4. To vest any movable or immovable property, rights or interests required by or received or belonging to the Company in any person or company on behalf of or for the benefit of the Company and with or without any declared trust in favor of the Company

5. To purchase, build, carry out, equip, maintain, alter, improve, develop, manage, work, control and superintend any plants, warehouse, sheds, offices, shops, stores, buildings, machinery, apparatus, labour lines, and



houses, warehouses, and such other works and conveniences necessary for carrying on the main business of the Company.

26. 
